Logo Contest Rules

Eligibility:

Participants must be a resident of the City of Manteca.

How to Enter:

Submit an official submission form and a valid file version of your design to mantecasurveys@ci.manteca.ca.us and include the subject line: "Logo Contest".

Design Guidelines:

- Logos may have up to five colors.
- Artists may submit multiple designs, but they must be submitted as separate entries.
- The winner of the contest must be able and willing to make changes to the design, as requested by the City Manager.

Design Specifications:

- Submissions should contain no more than five (5) colors and be your original work using no photo images. By submitting a design, you are guaranteeing that you hold rights to everything in it, and that it does not contain any copyrighted material.
- Be clear and identifiable at small sizes (e.g. 2x2)
- Submit a clear design that can be rendered in multiple colors, black and white and gray tones. Font Color must be in contrast to background for readability.
- Submissions must be submitted in PDF, JPG, or GIF format only; however, please be prepared to provide high resolution/vector graphic versions of your work. (Hand drawn submissions will not be accepted)
- Submissions must be submitted in the following formats: full color, black and white and gray tone.
- Submissions may not exceed 10MB. We will ask the winner for a high resolution original file.

Submission Agreement:

- The City of Manteca reserves the right to make any adjustments deemed necessary to the winning design.
- The City of Manteca will have all rights to the winning design. By submitting an entry, you agree that if your design wins, it can be used by the City of Manteca on all promotional materials.
- All submissions must be emailed with the following information to be considered eligible: Full Name, Contact Email, and Contact Phone Number.

- By submitting and entering the contest, you are agreeing to all contest rules and are attesting to the originality of your design.

Judging and Selection of Winner

- The Logo Committee will determine the top three logo designs. The top three designs will then go to a vote of city staff and the public. The design with the most votes will be the logo contest winner.
- The vote will be final.
- The Logo Committee reserves the right not to select a top three if, in its sole discretion, no suitable entries are received.
- The Logo Committee reserves the right to disqualify any Entrant or Entry at its sole discretion.

Intellectual Property:

- Any submitted idea, documentation, photograph or design entered in this contest will remain the exclusive property of the City of Manteca and the Entrant agrees that the City of Manteca shall have the perpetual, worldwide, irrevocable right to edit, publish and use these materials in any way and in any and all media now or hereafter known for trade, advertising, promotional and/or other purposes as the City of Manteca may determine in its sole discretion without further consideration to Entrant or winner.
- The Entrant agrees to assign all rights, title and interest into the submission, including copyright, to the City of Manteca and waives his/her legal rights in the submission.

Authorization to Use Winner's Name:

By submitting a design and accepting the contest prize, the winning Entrant permits the City of Manteca to make public and otherwise use the winner's name and submitted work without further compensation in any media now known or hereafter developed for promotional and/or publicity purposes, unless prohibited by law.
