

ROLL OFF CONTAINER BIN RESTRICTIONS

1. Bin rentals require a \$325.00 deposit. **A \$191.27 pulling fee + \$50.00 / ton tipping fee will be deducted from the deposit.** Customer will have either a credit or balance due depending on tipping fee which will be applied to their City account. If customer does not have a City account, they will be issued a check or receive an invoice for the balance due. Any requests for extra dumps will require an additional deposit fee.
2. Bin Rentals are for a two week period. Bin will be automatically picked up at the end of two weeks. 24 hour notice required for early pick up. There will be a per day fee charge for any time over the two-week rental period. A return trip charge will be assessed for any bins that are inaccessible due to being blocked by cars/locked gates.
3. Do not load over the top of the bin/drop box. An additional charge shall be assessed for any amount of refuse that is over the top of the bin. (minimum charges are \$41.49 / ½ hour - \$82.97 / hour). An additional charge will apply for any infractions including overweight and overloaded bins.
4. Clean dirt, roofing tiles, sod, cement (no wire, rebar or exposed metal) and asphalt may be placed in a 10 yd bin specifically designed for that purpose only. None of the above may be mixed. There will be an extra charge for cement with wire or rebar.
5. Roofing material of composition must be placed in a 16 yd bin only. Wood shake may be placed in any size bin from 16 yd to 40 yd.
6. **The customer shall observe the following bin restrictions and is solely responsible for materials in bin:**
 - No hazardous waste – oil, paint, solvents, etc.
 - No 50-55 gallon containers
 - No excessively heavy items – use common sense
 - No dead animals or tree stumps
 - No refrigerators, freezers or air conditioners
 - No car bodies, engines or transmissions
 - No cell phones, telephones or answering machines
 - No tires allowed (separate charge, place curbside)
 - No VCRs, mercury thermostats, thermometers
 - No microwave ovens, washing machines or dryers
 - No household batteries / car batteries
 - No televisions, computer monitors or other equipment with cathode ray tubes.
 - No fluorescent lamps, CFL's or sodium vapor lamps
 - No radios or stereos
 - No water heaters

Customer will be charged if any of the above items are found in bin.

7. All containers will be placed curbside only unless otherwise requested by customer. A charge will be assessed for any bin size change outs or relocations made after delivery.

HOLD HARMLESS AGREEMENT FOR PLACEMENT OF RENTAL CONTAINER

Customer shall assume the defense of and indemnify and save harmless City of Manteca, City's agents and employees, from all claims, liability, loss, damage and injury of every kind, nature, and description, directly or indirectly resulting from the placement of City furnished rental container on private property.
